# NOTICE OF RACE

### Venue

The Challenge will be held from 18th till 19<sup>th</sup> of August.

**Organizing authority is the SYCOD** Alfred Devoslaan 50 - B 8670 Oostduinkerke - Koksijde .Tel. 058/51.36.74

### Rules

The Championship will be governed by:

- 1.1 The world sailing Rules 2017-2020
- 1.2 The prescriptions of de KBYV- FRBY.
- 1.3 Boats may be required to present a valid publicity certificate delivered by their National Authorities.
- 1.4 The Sailing Instructions.

### Advertising

The Challenge is designed as a Category "C" event in accordance with ISAF Regulation 20 Advertising Code. The forward 25% of the hull on each side of all participating boats shall display only the advertising chosen (and required to be displayed) by the event organiser.

### Eligibility and entries

The Raf Verhaeghe Challenge is open to all multihull from the classes C1 – C3 – C4 listed in the SCHRS rating.

All entrants, to be eligible for the challenge, shall:

- Comply with ISAF Regulation 19 Eligibility Code.
- Be current financial members of their National Multihull Association.
- Any competitor under the age of 18 years will be required to obtain parental/guardian consent prior to commencement of Challenge.

### Fee

The Entry Fee is 50,- €/boat. (40,-€ for solo boats). Participants can participate to the diner on Saturday evening by separate on-line registration and have to subscribe during their registration at the regatta office.

Payments (cash only) shall be received on site during registration.

### Measurements and certificates.

- Each boat shall produce a valid measurement certificate at registration. To prevent any dispute, no fundamental measurement has to be done on the spot.

### Sailing Instructions

The Sailing Instructions will be posted on the official notice board and available on request on completion of registration.

### Courses

The Challenge will use windward / leeward courses with a gate.
